UKINUTO VANREDNO STANJE U REPUBLICI SRBIJI

Dana 06. maja 2020. godine Narodna skupština Republike Srbije donela je Odluku o ukidanju vanrednog stanja (u daljem tekstu: „*Odluka*“) koja je stupila na snagu dana 07. maja 2020. godine.

Odnosnom Odlukom ukinuto je vanredno stanje u Republici Srbiji koje je proglašeno dana 15. marta 2020. godine.

Istog dana, Narodna skupština Republike Srbije donela je Zakon o važenju uredaba koje je Vlada uz supotpis predsednika Republike donela za vreme vanrednog stanja i koje je Narodna skupština potvrdila (u daljem tekstu: „*Zakon*“).

Zakonom je uređeno važenje uredbi donetih za vreme vanrednog stanja, te određene uredbe prestaju da važe dana 07. maja 2020 godine, i to:

- Uredba o merama za vreme vanrednog stanja;
- Uredba o organizovanju rada poslodavca za vreme vanrednog stanja;
- Uredba o poreskim merama za vreme vanrednog stanja radi ublažavanja ekonomskih posledica nastalih usled bolesti COVID-19 izazvane virusom SARS-CoV-2;
- Uredba o korišćenju finansijskih sredstava budžeta Republike Srbije za vreme vanrednog stanja nastalog

THE STATE OF EMERGENCY HAS BEEN LIFTED IN THE REPUBLIC OF SERBIA

On May 6, 2020, the National Assembly of the Republic of Serbia has passed the Decision on the abolition of the state of emergency ("*Decision*"), which entered into force on May 7, 2020.

The relevant Decision abolished the state of emergency in the Republic of Serbia, which was declared on March 15, 2020.

On the same day, the National Assembly of the Republic of Serbia passed the Law on the validity of regulations, which the Government, with the co-signature of the President of the Republic, made during the state of emergency and which the National Assembly confirmed ("*Law*").

The Law regulates the validity of regulations issued during a state of emergency, and certain regulations expire on May 7, 2020, namely:

- Regulation on measures during a state of emergency;
- Regulation on organizing the work of the employer during the state of emergency;
- Regulation on tax measures during the state of emergency in order to mitigate the economic consequences caused by the COVID-19 disease caused by the SARS-CoV-2 virus;
- Regulation on the use of financial resources of the budget of the Republic of Serbia during the state of emergency caused by the disease

- Uredba o rokovima u sudskim postupcima za vreme vanrednog stanja proglašenog 15. marta 2020. godine;
 - Uredba o ograničavanju maloprodajne cene zaštitnih sredstava za vreme vanrednog stanja nastalog usled bolesti COVID-19 izazvane virusom SARS-CoV-2;
 - Uredba o posebnim tehničkim zahtevima, standardima i primeni medicinskih sredstava za vreme vanrednog stanja nastalog usled bolesti COVID-19 izazvane virusom SARS-CoV-2;
 - Uredba o načinu učešća optuženog na glavnom pretresu u krivičnom postupku koji se održava za vreme vanrednog stanja proglašenog 15. marta 2020. godine;
 - Uredba o dodatnom zaduživanju za vreme vanrednog stanja nastalog usled bolesti COVID-19 izazvane virusom SARS-CoV-2 uzimanjem kredita, emitovanjem državnih hartija od vrednosti na domaćem i međunarodnom finansijskom tržištu i davanjem garancija Republike Srbije;
 - Uredba o organizovanju rada ustanova socijalne zaštite za smeštaj korisnika i organizacija socijalne zaštite za pružanje usluge domskog smeštaja za vreme vanrednog stanja; kao i
 - Uredba o ispravama koje moraju da prate robu u prevozu za vreme vanrednog stanja nastalog usled bolesti COVID-19 izazvane virusom SARS-CoV-2.
- COVID-19 caused by the SARS-CoV-2 virus;
- Regulation on deadlines in court proceedings during the state of emergency declared on March 15, 2020;
 - Regulation on limiting the retail price of protective equipment during the state of emergency caused by the COVID-19 disease caused by the SARS-CoV-2 virus;
 - Regulation on the Specific Technical Requirements, Standards and Application of Medical Devices for the Emergency of COVID-19 Disease Caused by the SARS-CoV-2 Virus;
 - Regulation on the manner of participation of the accused in the main trial in the criminal proceedings held during the state of emergency declared on March 15, 2020;
 - Regulation on additional borrowing during the state of emergency caused by the COVID-19 disease caused by the SARS-CoV-2 virus by taking loans, issuing government securities on the domestic and international financial markets and providing guarantees of the Republic of Serbia;
 - Regulation on organizing the work of social protection institutions for accommodation of beneficiaries and social protection organizations for providing home accommodation services during a state of emergency; as well as
 - Regulation on the documents required to accompany goods in transit during the emergency caused by COVID-19 caused by the SARS-CoV-2 virus.

Odredbe navedenih uredbi primenjivaće se samo na učinioce prekršaja koji su tim

The provisions of the named regulations shall apply only to the perpetrators of the offenses

uredbama propisani, a koji su učinjeni za vreme vanrednog stanja.

prescribed by those decrees, which were committed during the state of emergency.

Ostale uredbe donete za vreme vanrednog stanja važiće do dana stupanja na snagu odgovarajućih zakona.

Other regulations issued during the state of emergency will be valid until the day the relevant laws enter into force.
